

**DECLARATION FOR PARTICIPATION IN THE K3 ULTRA COMPETITION AND ITS ACCOMPANYING EVENTS**

This declaration is in the nature of a written agreement between the Participant and “K3 Ultra Sports and Tourism Club”, in its capacity as the Organizer of the sports event. By signing it, the parties express their mutual agreement on all the conditions described. All disputes arising from the interpretation and implementation of this declaration will be resolved in accordance with the current legislation of the Republic of Bulgaria.

**I. INFORMED RISK-TAKING**

I hereby declare that I have been duly informed of the nature of the K3 ULTRA race and accept personal responsibility for the risks inherent in participating in high-exercise mountain running and varying weather and terrain conditions. I understand that participation may result in physical injury, dehydration, allergic reactions,

falls, collisions, heat stroke, exhaustion and other accidents.

I voluntarily participate in the competition, I am aware of the physical exertion involved, and I take personal responsibility for the consequences.

**II. HEALTH CONDITION AND PHYSICAL TRAINING**

I realize that it is my responsibility to be physically prepared and properly equipped according to the requirements of the organizer.

I confirm that my health condition allows me to participate in mountain running with high physical exertion and there are no contraindications for this.

I confirm that I will support my above statement in one of the following ways:

1. I will provide a medical certificate regarding my health condition and the absence of contraindications for participation in mountain running with high physical exertion, which will meet the following requirements of the organizers:

- Issued by a medical institution registered under the relevant applicable medical law,
- signed and stamped by a Doctor with valid medical capacity,
- issued no earlier than 72 hours before the start of the competition

or

2. I confirm that I am part of a sports club and have already passed an annual medical examination, and I will provide an official document from the club or federation certifying the regular control.

or

3. I confirm that if I cannot present a medical document, I will undergo an examination by a Medical Team provided by the organizer of the sports event.

I am fully personally responsible for the authenticity of the provided medical document, and I take the responsibility for all legal and organizational consequences in case of establishing false data or misleading information.

I understand that the organizer is not responsible for consequences arising from false or misleading information provided by me.

I understand that the organizer has the right, at its discretion, to request additional information or documentary verification on the spot, without engaging with an expert check of each declaration.

**III. LIMITATION OF THE ORGANISERS LIABILITY**

I understand that the organizer is obliged to provide reasonable safety measures, including route markings, medical support and volunteers. I agree that the organizer is not responsible for damages incurred arising from the usual risks of participation in the competition and its accompanying events, unless they arise from gross negligence or failure to fulfill basic organizational obligations.

**IV. RESPONSIBILITY OF THE PARTICIPANT**

I accept that I am responsible for my actions and inactions during the competition and its accompanying events. In case I violate the rules and cause damages to third parties or the organizer through my actions, I undertake to compensate for the direct damages caused and the costs incurred, including legal ones.

I further state that:

- I am obliged to possess and wear/carry during the race the mandatory equipment in accordance with the distance I have chosen, according to the published requirements of the organizer. The organizer has the right to carry out checks at registration, at checkpoints and at the finish. The absence

of a mandatory element of the equipment leads to immediate disqualification.

- I undertake to comply with all instructions of the organizer, volunteers and medical staff, including those related to the safety of the route and actions in case of an accident.
- I agree not to leave the marked routes, not to receive help outside the points designated by the organizer, not to pollute the environment, and to show respect and cooperation to the other participants and the organizer’s team.
- When passing through populated areas, running on or crossing roads with traffic or areas of potential danger, I undertake to comply with the traffic rules in the Republic of Bulgaria and to be vigilant and cautious in order to protect my own life and the safety of other persons.

**V. MEDICAL CARE AND INSURANCE**

I understand that in the event of an accident during the competition, I will be provided with medical assistance by licensed medical professionals or trained volunteers. I am aware that for the period of the competition I am included in a group accident insurance concluded by the organizer, which covers the main risks in case of accidents. I also understand that I can take out additional personal insurance with extended coverage on my own initiative.

**VI. RULES AND DISQUALIFICATION**

I am familiar with the rules for participation published by the organizer.

If I do not comply with the specified cut-off times, I accept that I will be entered as “DNF”; (“did not finish”). The organizer has the right to terminate my participation in case of a threat to my health or violation of the competition rules.

**VII. CHANGES AND FORCE MAJEURE**

I accept that in the event of extraordinary circumstances beyond the control of the organizer – including, but not limited to: natural disasters,

extreme weather conditions, epidemics, pandemics, terrorist threats, accidents, administrative or institutional prohibitions, or other unforeseeable and insurmountable circumstances – the organizer has the right to make changes to the route, postpone, suspend or cancel the event in whole or in part.

I confirm that in such cases the organizer does not owe a refund of the participation fee. If possible, the Organizer will offer an alternative date, participation in a future competition or event or other reasonable form of compensation, and the compensation may not exceed the fee paid.

I accept that in the event of force majeure (for example, but not limited to, natural disasters, prohibitions by institutions, technical obstacles), the organizer has the right to change, postpone or cancel the event without owing a refund of the participation fee.

**VIII. PROTECTION OF PERSONAL DATA**
