## I. INFORMED CONSENT AND RISK-TAKING

I hereby declare that I am duly informed of the nature of the K3 ULTRA race, the tracks, terrain and climatic hazards, physical exertion, and the risks, which include, but are not limited to: trauma, exhaustion, dehydration, allergic reactions, falls, collisions, heat stroke, exhaustion and other incidents.

## II. HEALTH CONDITION AND PHYSICAL TRAINING

I confirm that I am aware of the health status of the person under 18 years of age, whose legal representative I am, that he/she:

- does not suffer from chronic diseases, including but not limited to asthma, epilepsy, heart disease or allergies that would make it difficult for them to participate;
- has not undergone active drug therapy at the moment;
- has not suffered severe injuries or surgical interventions in the last 6 months.

I confirm that the information provided in the "Health Questionnaire" regarding the health status of the person under 18 years of age, whose legal representative I am, is true and accurate and the person is physically and mentally prepared to participate in the competition and there are no contraindications for this.

I confirm that at the time of signing this declaration, I am not informed of any health conditions that pose an increased risk of participation. If in doubt, I undertake to present a medical certificate before the start of the race.

I am fully personally responsible for their reliability and assume all legal and organizational consequences in case of establishing false or false data.

I understand that the organizer is not responsible for consequences arising from false or misleading information provided.

I understand that the organizer reserves the right, at its discretion, to request additional information or documentary verification on the spot, without engaging an expert check of each declaration.

## III. LIMITATION OF THE ORGANISER'S LIABILITY

I understand that the organizer is obliged to provide reasonable safety measures, including route marking, medical support and logistics. I agree that the organizer is not responsible for incidents arising from the usual risks of participation in the competition and its accompanying events, unless they arise from gross negligence or failure to fulfill basic organizational obligations.

I declare that I will not make any claims against the Organizer for material or non-material damages arising in connection with the participation of the person under 18 years of age in the competition, unless they are caused due to intentional guilt or gross negligence of the Organizer proven before a competent court.

#### **IV. RESPONSIBILITY OF THE PARTICIPANT UNDER 18 YEARS OF AGE**

The participant under 18 years of age, through his/her legal representative, confirms that:

- She/He voluntarily participates in the competition, is aware of the physical exertion involved, and takes personal responsibility for the consequences.
- During the competition, she/he will wear/carry the mandatory equipment in accordance with the distance chosen by her/him, according to the published requirements of the organizer. The organizer has the right to perform checks at registration, at checkpoints and at the finish. The absence of an element of the mandatory equipment leads to immediate disqualification.
- The participant undertakes to comply with all instructions of the organizer, volunteers and medical staff, including those related to the safety of the route and actions in case of an accident.
- She/He agrees not to leave the marked routes, not to receive assistance outside the points designated by the organizer, not to pollute the environment, and to show respect and cooperation to the other participants and the organizer's team.
- When passing through populated areas, running on or crossing roads with traffic or areas of potential danger, the participant is obliged to comply with the traffic rules in the Republic of Bulgaria and to be vigilant and cautious in order to protect her/his own life and the safety of other persons.

#### **V. MEDICAL CARE**

I give my consent, in the event of an accident during the competition, the person under 18 years of age, whose legal representative I am, be provided with medical assistance by licensed medical personnel and/or trained volunteers.

I understand that I can, on my own initiative, conclude Health Insurance with Extended Coverage for the Person.

#### **VI. RULES AND DISQUALIFICATION**

I am familiar with the rules of participation published by the organizer and I have introduced them to the Person under 18 years of age whom I represent.

#### **VII. CHANGES AND FORCE MAJEURE**

I accept that in the event of extraordinary circumstances beyond the control of the organizer – including, but not limited to: natural disasters, extreme weather conditions, epidemics, pandemics, terrorist threats, accidents, administrative or institutional prohibitions, or other unforeseeable and insurmountable circumstances – the organizer has the right to make changes to the route, postpone, suspend or cancel the event in whole or in part.

I confirm that in such cases the organizer does not owe a refund of the participation fee. If possible, the organizer will offer an alternative date, participation in a future competition or event or other reasonable form of compensation, and the compensation may not exceed the fee paid.

I accept that in the event of force majeure (for example, but not limited to, natural disasters, prohibitions by institutions, technical obstacles), the organizer has the right to change, postpone or cancel the event without owing a refund of the participation fee.

### **VIII. PROTECTION OF PERSONAL DATA**
